# Spotlight: Surgery Department

## Members of your trusted healthcare team

The goal of our surgery department is to provide local services that allow patients an opportunity to recover at home. To ensure that our patients receive the care they deserve we offer surgical services to accommodate patients of all ages and use a multidisciplinary approach working closely with our local providers, physical therapy, x-ray, laboratory, dietary, respiratory therapy and nursing.

### **SURGICAL SERVICES OFFERED BY CCGH:**

**General Surgeries** - Our general surgeon offers a wide variety of services to our community which include laparoscopic and open surgeries of the gallbladder and appendix. As well as lipoma removals, hernia repair, intestinal obstructions, port and peg tube insertions and skin grafts. Our general surgeon also does EGD's and colonoscopy weekly.

**Orthopedic Surgeries** - Our orthopedic surgeons offer a wide variety of orthopedic surgeries. This includes joint injections and aspirations, wound irrigation and debridement, hand surgery including carpal tunnel. They offer arthroscopic surgeries for knees and shoulders as well as total replacement of knees, shoulders and hips. They are also able to provide fracture fixation, along with many other services.

**Urology Surgeries** - We are able to serve our community a wide variety of urology services for both the young and old. Urology services include, cystostomy, urodynamic procedures on the bladder, endoscopy, cystoscopy, urethroscopy of the bladder. We also offer a wide variety of bladder procedures, prostate biopsy, prostatectomy and transurethral resections.

**Ear, Nose and Throat** - Surgeries offered include thyroidectomy, scar excision, excision of skin lesions, myringotomy, septoplasty and sinus surgeries.

**Podiatry** - Services offered include digit amputation, hammer toe correction and debridement of abscess and ulceration.

### BAKED POTATO SALAD

- 4 ½ pounds potatoes, peeled and cut into ¾ inch chunks
- ¼ cup olive or vegetable oil

In a large bowl, toss the potatoes with oil and dressing mixes. Place in two greased 13 in x 9 in x 2 in baking pans. Bake, uncovered, at 400 degrees for 45 minutes or until tender. Cool. Transfer to a large bowl; add peppers, onions, tomatoes, eggs and bacon. Toss gently. Combine remaining ingredients in a small bowl; mix well. Pour over salad and stir gently. Cover and refrigerate for at least 1 hour. Yield: 16-20 servings.
