Spotlight: Cardiac Rehabilitation Dept

Members of your trusted healthcare team

CCCH is so excited to offer Cardiac Rehabilitation Services in our community. The benefits of these services go far beyond improving our patients' heart health. They include: Strengthening the entire body, lowering the risk of hospitalization, relieving symptoms, improving quality of life and improving mood and mental health.

Our Chase County Cardiac Rehab Program was first launched in Imperial, NE in August of 1988 by Cindy Arterburn, RN. It was initially created in a satellite location and then transitioned to the current location in the hospital in 1991. This was the first rehab program of its kind offered in Southwest Nebraska. Initially, there were 3-4 group times offered. It has since grown to 8 group times every Monday, Wednesday, and Friday in which 20-28 patients attend on a daily basis.

There are three different phases of cardiac rehab. Phase I is inpatient cardiac rehabilitation that patients complete during their hospital stay.

Phase II rehab is physician prescribed following an acute cardiac event. This phase typically lasts approximately 3 months and is beneficial for patients who need to strengthen their heart muscles in a safe, controlled, and supervised environment. An additional benefit of Phase II cardiac rehab is that it includes a close monitoring for any subsequent cardiac changes or problems. Finally, this phase provides patients with confidence in self-care and knowledge of a heart healthy lifestyle.

Phase III rehab is a fee-based maintenance program that is offered to patients who wish to continue to exercise in a supervised environment. Patients value and enjoy the safety of a supervised environment, exercise accountability, and availability of exercise equipment. They also appreciate the social and supportive atmosphere this program provides.

Cardiac Nuclear Stress Testing is an additional Service offered by the CCCH Cardiac Rehab department every Thursday. Stress testing is provider ordered and can detect possible heart blockages. This is beneficial for patients who are at risk for cardiac disease and having cardiac symptoms or are preparing for surgery.

Recipes by Rhonda

Shamrock Cutout Pound Cake

2 pkg (16 oz each) pound cake mix
10 drops green food coloring
½ Tsp peppermint extract

Glaze

1 cup confectioners' sugar
1/8 tsp peppermint extract
3 to 5 tsp 2% milk



Preheat oven according to package directions. Grease a 9x5 in loaf pan. Prepare one package cake mix according to package directions, adding food coloring and extract before mixing batter. Transfer to prepared pan. Bake and cool as package directs.

Cut cooled cake into 1 in slices. Cut with a shamrock shaped cookie cutter (save extra cake for another use). Stand shamrock slices at an angle in a greased 9x5 in loaf pan.

Prepare second cake mix according to package directions. Pour batter around and over shamrock slices. Bake and cool as package directs.

For glaze, in a small bowl, mix confectioners' sugar, extract and enough milk to reach desired consistency. Pour glaze over cake, allowing some to flow over sides.

Extra pound cake may be cubed and served in dessert dishes, layered with warm fudge sauce.

Village of Wauneta Meeting Minutes

A meeting of the Board of Trustees of the Village of Wauneta, Nebraska, was convened in open and public session at 6:30 p.m. on **February 13, 2024**, at the Wauneta Village Office.

Pledge of Allegiance was given.

Chairman Johnston publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review.

Present: B Kramer, R Einspahr, P Johnston. Absent: C Walgren, B Goings.

Guests: Michael Hoback (AMGL), Arlan Wine (Village Attorney) and RaNae Richardson (WCTC)

Notice of the meeting was given in advance thereof by publication in the Imperial Republican on February 8, 2024. Notice of this meeting was simultaneously given to the Chairman and all the Trustees. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Michael Hoback, AMGL, gave a presentation and reviewed the financial statements and audit report for the Village of Wauneta, for the year ending September 30, 2023. Hoback went through the report in detail with the Board. Hoback also reviewed several benchmarking ratios to show the Board how the Village of Wauneta compares to towns of comparable population.

Board approved the minutes of the regular meeting of the Village Board of Trustees, held on January 9, 2024.

Board Treasurer's Report (Jan) and approved bills (Feb) as presented.

Richardson, Johnston and Einspahr gave a report of the Dec 2023 WCTC Financial Reports and Committee Meeting to the rest of the Village Board.

Board approved updates to Employee Policy #9.0 "Holidays" for WCTC and approved new Employee Policy "Sick Leave Pay for Workers with a Positive COVID-19 Illness" for WCTC.

Board approved the purchase of a new dryer for WCTC for \$6230.00; and the purchase of a new door alarm panel from Spectronics for \$1200.00.

The Board reviewed the Chase County Sheriff's Report for January 2024.

The Village received a letter from the Chase County Commissioners regarding the Contract for Police Services with the Sheriff's Department. They are proposing an increase in the annual fee that the Village pays to Chase County, from \$22,000.00 to \$36,480.00. The Board discussed the proposal and will send several Board members to the next Commissioner's meeting to discuss the proposed increase further with the Commissioners.

Board approved the updated "Emergency Plan" for the Village of Wauneta Water System.

Board approved a wage increase for Amanda Ziegler (Library Director), from \$12.00 to \$13.00 per hour, effective January 1, 2024, based on the recommendation from the Library Board.

The Village Board accepted Sharon Haarberg's resignation from the Library Board.

The Board reviewed and discussed a summary and analysis of current electric rates. The Board discussed and proposed implementing a 5% rate increase. Skelton will prepare the necessary ordinance and present it at next month's meeting. Skelton will also research having a formal rate study done.

The Board discussed a grant opportunity through Southwest Nebraska Community Betterment Corp (SWNCBC). The grant is for new home construction. The Board approved to participate in the grant application with SWNCBC, committing to a \$25,000 cash match and donating a lot with infrastructure (if the grant is awarded).

Board approved the write-off of past due utility accounts, in the amount of \$4115.41.

Board approved hiring John Fuller as a seasonal employee (during winter months for snow removal).

The Board discussed the property at 167 N. Arikaree, which is a nuisance property. Notice has been sent to the appropriate parties and no response has been received. The Village will move forward with Nuisance Abatement as proposed.

The Board discussed the Office elevator which has been out of service for some time. The Village received a quote from Schindler Elevator to replace the obsolete board and selector (cost of \$19,000.00). We will investigate additional options to have it repaired.
